- A pup MUST be paid for before it leaves the breeder- this means that a **personal check** MUST clear our bank **2 weeks prior to the pet leaving the premises**. We will take CASH OR *cashier's check* from a MAJOR bank only. Venmo is desirable. Please plan accordingly!
- We WILL NOT sell to a dilute breeder- This means ANY silvers, charcoal, or champagne Labradors.
- Deposits must be paid in full and a signed contract received to hold a place **within 1 day of a verbal phone agreement on a pup**.
- We retain the right to refuse sale or full registration to anyone. The sale must be to the original owner of puppy only and is **non-transferrable to second parties**.
- Dog MUST be picked up and paid for IN FULL at 8 weeks of age. **Any extra time a pup is here results in a fee of \$65 per 24 hours**.
- All initials within reflect BINDING notice and agreement.

24 **DEPOSITS, PAYMENTS AND LITTER INFORMATION**

25 Deposits are \$500 to hold a pup and **are not refundable.** They are created on a “first deposit, first pick  
26 bases. **Changing litter choice after deposit places you in the next available slot ON THE NEW LITTER to**  
27 **honor those ahead of you on the list.**

28 We accept and encourage clients to utilize Venmo for payments. Our email is our account:  
29 [wolfedenretrievers@gmail.com](mailto:wolfedenretrievers@gmail.com) or Colette Dickmeyer@ Colette Dickmeyer. Payments MUST be made  
30 as **“friends”** on Venmo. If someone other than the named owner makes a payment it must be written by  
31 your name on page 1.

32 Deposits may be placed on a current or future litters. A placement will be given (# 1,2,3 etc...) based on  
33 dated receipt of a signed contract **and** deposit. Kennel always reserves right of first pick for the breeding  
34 program. Should a pup in the litter become ill or not pass the veterinary health inspection, the entire  
35 litter will move in accordance by date of deposit to accommodate for the sick pup.

42 Please respect that in order to protect the kennel and puppies from any deadly virus such as parvo, we  
43 **do not** allow home visits before the 8 week puppy pick time. You will be **required** to disinfect your shoes

44 upon arrival. We utilize "Facebook Live" on our Wolfe Den Retrievers Facebook page and **work with you**  
45 **individually by phone and videos** to choose your pup. Continued...

46 Picks are in order of deposits. Clients MUST Pick out their pup by 6-7 weeks to allow enough time for  
47 each client in the litter to choose behind you. If a pick is not chosen by week 7, breeder will choose your  
48 pup to allow other clients to make their choice. . \_\_\_\_\_ **Client initials**

49 **PUPPY GO HOME DAY**

50 A "pick up date" will be determined at 8 weeks of age. In order to accommodate each family, we  
51 schedule ½ hour for you to get your pup. We wish for everyone to get a personalized experience where  
52 you will receive AKC paperwork, a small bag of puppy food and time to ask any questions. You may wish  
53 to bring a toy or small blanket to rub on mama. We always love sharing pictures on our FB and web  
54 page of you and your family with the new baby by our sign! Let us know if you don't wish us to share  
55 your photo.

56 **If pup is not picked up by the 61<sup>st</sup> day of the pup's life, deposit may be forfeited, and pup may be sold**  
57 **to another buyer. A \$65 fee per day will be incurred beginning on day 61 as training is imperative to**  
58 **begin at 8 weeks.** The breeder's acceptance of funds serves as agreement to this contract.

60 **DEFINITIONS**

61 "Puppy" is defined as an American Pointing Labrador Retriever, which is in excellent health at the time  
62 of the sale and embodies the characteristics of the American Pointing Labrador breed. This pup is  
63 purebred and is registerable with the American Kennel Club –(AKC), United Kennel Club (UKC) or  
64 American Pointing Labrador Association (APLA). \_\_\_\_\_ **Client initials**

65 **AKC REGISTRATION**

66 Directions for registering your pup will be on the AKC paper registration certificate given to you. We  
67 recommend doing this on-line. **Dogs registered for titling or breeding MUST have "Wolf Den**  
68 **Retrievers" or a derivative in the name on any AKC, UKC or APLA registration.** A Fine in the amount of  
69 \$15,000 may be enforced for failure to comply. \_\_\_\_\_ **Client initials**

70 **BREEDING**

71 We have worked extremely hard to establish our unique bloodlines. For this reason,  
72 WDR's holds a "**limited**" registration for breeding status on ALL pups unless it is discussed and indicated  
73 on a certain breeding or dog / puppy mentioned below... Breeding rights may incur an additional one-  
74 time expense.

78 **BREEDING RIGHTS CONTINUED**

79 Should a client obtain an open registration status, we **require** that they complete ALL current genetic  
80 health panel screening tests through Paw Print Genetics or other, in addition to OFA hips, elbows eye  
81 screenings with registered scores. As a breeder, you **must** also require this of the chosen mate. We  
82 require titles in AKC, UKC and or APLA BEFORE breeding. Breeding will not be allowed within a 500 mile  
83 radius of our kennel. A \$15000 fine for non-compliance **per occurrence (pup produced) will be applied.**

89 **Buyer agrees not to breed any 2 dogs that “carry” a negative genetic disease trait as this would create**  
90 **an affected pup. Dilute breeding is absolutely not allowed in our lines. Should this happen, a \$15,000**  
91 **per occurrence (puppy) will be fined to the owner.**

92 Professional breeding purebred lines is an art form. Dogs should not be bred without thorough research

#### WARRANTIES AND LIABILITIES

96 **Breeder** warranties above-described pup to be healthy at time of the sale and will provide a veterinary  
97 health check certificate.

98 **Breeder** does not assume any liability for any injury to pup after delivery to buyer. Injury to hips and  
99 elbows as well as spay/neuter before age 2 can cause faulty radiographs and health defects and will void

#### CLIENT RESPONSIBILITIES

103 **The Buyer agrees to have the puppy examined by a licensed veterinarian within 72 hours of delivery**

104 and conduct an individual stool sample check. ( see parasites...)

105 If pup is found to be anything other than healthy (**excluding parasites**) by the buyer’s vet, it shall be  
106 returned immediately with all registration papers, bills of sale and other items given to the owner in the

#### BREEDER RESPONSIBILITIES

110 WDR will take the ill pup to a licensed vet for diagnosis. If pup is given a clean bill of health, no  
111 replacement will be given and all rights to the puppy by the buyer will be forfeited. If a disease or illness  
112 is diagnosed, the buyer may get a replacement pup from the same or future litter within 1 year, equal to  
113 the value of their pup’s litter. **Buyer MUST** pay the difference for a greater value future breeding. **We**  
114 **do NOT refund cash.** \_\_\_\_\_ **Client initials**

#### GENETICS AND HEALTH GUARANTEE

117 **Rarely**, a medical “fluke” will emerge, sometimes generations down the line and there is no way it can  
118 be prevented. Should an *essential paw print genetic panel defect or hip dysplasia*  
119 present itself that inhibits the quality of life, or prevents breeding of the dog, the buyer may “return”  
120 the puppy for a replacement pup from the next available Den litter **of equal value only**. This will be in  
121 effect **ONLY** as long as the business is active and puppies are being produced.

122 Dew claws may be removed- however, we **cannot** guarantee that they will not at times grow back. We  
123 do not guarantee elbows due to too many environmental factors.

124 **RE-sale of your pup to a second party nullifies and voids the health guarantee.**

#### VACCINATIONS AND HEALTH GUARANTEE

128 Our pups have been vet checked and micro-chipped. You will need to register the micro-chip with **AKC-**  
129 **re-unite** (when you register your dog for their AKC papers online) for a minimal fee to assure your pet is

**PARASITE PREVENTION**

We remain consistent in reminding our new owners to remain vigilant and aware of the dangers of parvo-virus, parasites, and other communicable diseases until pups have acquire ALL of their pup-series shots TO BE DETERMINED BY YOUR VET. **All Pups are wormed with Pyrantel, a broad spectrum dewormer.** You must acquire a stool sample check with your vet immediately to screen for individual parasites. **YOUR personal environment is key to eliminate ALL pediatric parasite possibilities.** Parasites are extremely common in puppies and not covered beyond this prevention. Discuss a flea, tick, heartworm prevention that you're comfortable with as ALL have some risks. PUPS HAVE VERY LOW IMMUNITY -PLEASE avoid public areas where dogs are "aired" until your pup is older and has obtained ALL vaccines. **Parvo travels on shoes!** We encourage utilizing a bleach/ water shoe bottom dip at your home's entrance to help eliminate Parvo-Virus. \_\_\_\_\_ **Client initials**

The breeders have done **everything possible** to produce healthy, genetically sound animals that are a credit to their breed. This has been accomplished by thorough research of backgrounds including but not limited to: parents, lineage, kennels and breeders of origin and titling in multiple venues. Our Adult dogs wait until 2-years of age for current genetic disease panel testing, OFA (hip dysplasia), and eye certifications. Even with all of this, no-one has been able to create an animal that is infallible. Like humans, they will age gracefully. With good breeding, these dogs have the greatest opportunity for a long, happy, healthy life with your family; enriching it in **many** amazing ways only a dog can do. \_\_\_\_\_ **Client initials**

**FEEDING AND CARE**

We feed **Purina Pro Plan 30/20 Sport Large Breed adult and puppy formulas.** We recommend clients to keep cans of **pumpkin pie filling and Purina Fortiflora probiotic powder** on hand for minor stomach and digestion issues. Request Lymes vaccinations and Bordetella yearly.

**For chewing,** we recommend Bene-bones, Nyla-bones and frozen carrots. NEVER leave a dog unsupervised when chewing ANYTHING as it could cause an obstruction. Collars should ALWAYS be removed on a dog when in your home or kennel. We do NOT recommend stuffed toys as they can be swallowed. Utilize bumper exercises and training as their reward and bits of dog food and praise for training treats. 90 percent of **behavior issues** stem from lack of obedience training and exercise. Start them young! \_\_\_\_\_ **Client initials**

**SPAY/NEUTER**

There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc.. **We require pups will not be spayed or neutered until at least 2 years of age.** Hormones are extremely important during growth years for bone and organ development. **Early spay/ neuter nullifies the health guarantee.** \_\_\_\_\_ **Client initials**

The **buyer** assumes the responsibility of carrying on with the age-appropriate vaccinations, exercises, and feeding schedule. It is important to keep your pup slim throughout its normal growth period. The breeder can offer NO further guarantees once the puppy is out of their control. \_\_\_\_\_ **Client initials**
